Full payment and signed contract for vendor space is due no later than Aug. 1st 2019. (No Space Will Be Saved - First Paid Gets The Spot)

| This agreement is made between St. Tammany Crab Festival (and or its Agent) andnamed Vendor. The Agreement is as follows: |

| The vendor will have their assigned vending area set up between the hours of 9am and 7pm on Friday Sept The vendor will disassemble booth area after the last band performs on Sunday Sept NO EXCEPTIONS! (Failure to set up booth during scheduled times will result in a forfeit of all vendor booth fees paid and loss of spot at the festival) |
| All vehicles must be off of the festival grounds by 9:00am on Saturday, Sept Vehicles not off the festival grounds will be towed at the vendor's expense. (vendors are encouraged to bring hand carts to transport additional product to their booth during the festival hours) |
| Except where approved by the Festival, there will be no duplication of any food items offered for sale. Food vendors will be allowed to sell bottled water and carbonated drinks (THAT ARE PURCHASED FROM THE ST. TAMMANY CRAB FESTIVAL). No alcoholic beverages or smoothies unless approved by The St. Tammany Crab Festival may be sold. Any violations to this regulation will result in the vendor being closed and asked to leave the festival grounds and will forfeit of all vendor fees paid and a loss of spot at the festival). |
| All alcohol vendors must have a current Louisiana State issued liquor license issued in the name of the vendor. A copy of these licenses must be provided to the festival and displayed in their booth. |

All vendors must comply with the appropriate Health Department and fire and life safety regulations, each vendor is responsible to keep the area around their booth clean in accordance to Health Department Standards, each booth must have a 5lb. fire extinguisher (ABC type and have current inspection tags, a type K fire extinguisher is required for vendors cooking with grease or deep fryers) the booths will be inspected by the Fire Marshall. Signs with their name, food items and prices should be placed on their booth and large enough to see from a distance. Disposing of oil and other waste will be the vendor's responsibility. Any vendor found dumping inappropriate material will be fined and immediately removed from the festival.

Vendors must provide the materials needed to set up on the grounds including but not limited to chairs, tables, tents, etc. These items will not be provided by St. Tammany Crab Festival.

Every effort will be made to provide water and power (if needed) to our vendors. You must provide exact power requirements and utility needs. You also must provide OSHA regulated extension cords. (12/3 100ft. extension cords)

St. Tammany Crab Festival is required to carry special event liability insurance coverage for the event. As a part of this coverage, the insuring agent requires that the festival obtain certificates of insurance from all merchandise vendors to verify proof of liability. All vendors must provide certificates of insurance to St. Tammany Crab Festival, naming St. Tammany Crab Festival and Deep South Entertainment L.L.C. additionally insured. NO EXCEPTIONS.

Limitations of Liability: St. Tammany Crab Festival and its agents assume no responsibility for property placed on the grounds by the vendor. St. Tammany Crab Festival is hereby relieved and discharged from all liability for any loss, injury or damage to persons' or property that may be sustained on the festival grounds. Security will be provided by The St. Tammany Crab Festival during and after the festival hours.
